FCC SUSPENDS LICENSES

An item in "The ARRL Letter Vol. 25, No. 29, July 21, 2006" starts out saying "The FCC has suspended two Amateur Radio licenses because the holders had failed to maintain correct mailing addresses in the Commission's licensee database." PLEASE NOTE: I recently checked the CARS data base against the FCC data base and several club members mailing addresses are not up to date in the FCC data base. I highly recommend that each of you check the FCC data and update your information if necessary. To check your information, on the Internet go to http://www.arrl.org. At the top of the page where it says "Call sign search" enter your call sign and click "Go". On the new page, "Page Down" once. If you don't have a computer with Internet access, go to a library or a friend's house. --- WA4GPS

FROM THE PRESIDENT

Let me start this month by thanking you for placing your trust in me for another year as the President of the CARS club. We truly have a wonderful group of folks in the club. And no fact punctuates this more than our continued record growth in membership. Our growth reflects a renewed commitment to the hobby of amateur radio, as well as, I believe, an understanding that we have a unique capability in a troubled world to cooperate and collaborate with others – particularly in support of our own domestic security.

To this end, a recent bill in the U. S. House of Representatives explicitly calls out Amateur Radio operators as part of an overall effort to enhance emergency communication at the Department of Homeland Security (DHS). The 21st Century Emergency Communications Act of 2006 (HR 5852), an amendment to the Homeland Security Act of 2002, passed the US House recently on a 414-2 vote and has gone to the Senate. HR 5852 calls for Amateur Radio operators to be part of a "Regional Emergency Communications Coordination Working Group" (RECC Working Group) that would be attached to each regional Department of Homeland Security office.

The RECC Working Groups would advise federal and state homeland security officials.

In the next year, I would like to set a goal for us to be a vital part of these working groups, should the measure go forward into law. Our work with the Hospital Emergency Amateur Radio Team (HEART) repeater system is a tangible example of the capability we as radio amateurs can deliver to our community. Leveraging the working groups may help us put those capabilities into focus for emergency officials, since membership in the RECC Working Groups would include state and local officials; law enforcement, first responders such as fire departments; 911 centers; hospitals; and ambulance services – the very people who can help us define and refine the many uses for the HEART network.

In addition, there may be opportunities to leverage relationships with communications equipment vendors, telephone, wireless, satellite, broadband and cable service providers, public utilities, and broadcasters to ensure that interference does not become a major impediment to amateur radio as competition for the airwaves heats up with exponential growth in the wireless market.

Come join us on August 14 at our next club meeting at Ryan's Steak House on Highway 61. I look forward to seeing you there.

2 Meter USB PSK63 Net

A group of hams in the greater Charleston area has started a PSK63 net. The Lowcountry 2 Meter USB PSK63 Net meets every Wednesday evening at 8 PM and every Sunday evening at 9:30 PM. The net uses PSK63 in the USB mode on 144.145MHz. Net Control is Skip Teller, KH6TY, developer of the popular Digipan software, who lives in Mt. Pleasant. Everyone with a multimode radio like an IC-706 type radio, a simple, standard PSK interface, and any type of ham license can participate. In the local area a vertical antenna will suffice even though most people use horizontal polarization. The net uses PSK63 rather than PSK31 because it is faster so it will give Net Control the opportunity to replay what a station sent when not all net participants can hear each other. It is an informal rag chew net and everyone is invited to participate. The Digipan software is free and can be downloaded at http://www.digipan.net. Digipan can be for both PSK31 and used PSK63. Emergency Prep: Bill WA4WGP, Charleston; John W4HNK, Dorchester; Vince KI4AOC, Berkeley

The June simulated emergency drill went well. Club members were encouraged to register with ARES [Amateur Radio Emergency Service] or RACES [Radio Amateur Civil Emergency Service] if volunteering for emergency operations.

John W4HNK shared information regarding online courses available via the FEMA website: http://training.fema.gov/EMIWeb/IS/. John recommended courses: ICS-100 & IS-700, which explain incident command systems and are useful courses to any volunteer wanting to assist during a disaster.

Glenn, WB4UIV, who has been serving as the liaison with the Red Cross made an appeal for someone to take his place, as Glenn now has work-related responsibilities during future disasters. Glenn noted that the volunteer would need to attend one meeting per month at the Red Cross building on Rivers Avenue.
