## FROM THE PRESIDENT

We start the new year with Amateur Radio heading into another storm. Broadband Over Powerline (BPL) technology has been given unprecedented leniency by the FCC with respect to interference with licensed services such as Amateur Radio, and ARRL has responded with a planned lawsuit that may run for several years. In addition, this month, the FCC summarily dropped the morse code requirement for all Amateur Radio license classes - deeming the current regime of written examinations "sufficient to determine whether a person is qualified to be issued an Amateur Radio operator license."

Once again, we find that the "traditions" of Amateur Radio, and the training ground for good operating practices that have distinguished our hobby from unlicensed services have been annexed by expediency. The FCC failed to see the benefit of keeping the challenge of the code in place to ensure a higher degree of dedication and conduct in the Amateur service stating, "The record is devoid of a demonstrated nexus between Morse code proficiency and on-the-air conduct...".

So, going forward into 2007, we need to keep our eyes on the future of Amateur Radio. CARS provides a solid foundation from which the entry-level amateur can continue to build knowledge and skills. A VE exam alone cannot do the job. Education and selfpolicing keeps our hobby at a high level of conduct. And part of self-policing is making sure that we get new Hams off to a good start. For it's so much easier to reinforce good habits than to break the bad!

In my invocation for the holiday party, I asked for guidance to find the wisdom in every voice. While we may have divergent opinions on issues such as those above, we all share a common interest in the hobby. Let's make sure that we're always looking for that kernel of wisdom!
