## FROM THE PRESIDENT

Life is paradoxical sometimes. Recently, the FCC decided to remove the Morse code requirements for amateur licensure, which seemed to have no interest outside of our amateur radio community. It seemed just a natural evolution. But in fact, the decision garnered tremendous public attention for our hobby.

I received a call from the <u>Post and Courier</u> a few weeks ago by a reporter who picked up on an Associated Press story on the FCC decision, and wanted to write a local story to complement the national headline. We got a nice article in the paper that not only placed local amateur sentiment on the code decision in a positive light, but also generated a letter to the editor several days later from Judge Alex Sanders, the venerable former president of the College of Charleston, a founder of the Charleston School of Law, and a former appeals court judge and state legislator.

In his letter, Sanders eloquently ties the technological advance of Samuel Morse to the natural evolution of all communication that moves information in the modern world – even the internet. It was instructional to me to think on Sander's analysis that, prior to the code, the fastest means possible of carrying a message from point A to point B was no faster than the human body! And all of this happened right here in

Charleston, since Morse moved to Charleston in 1813. What a valuable instance of earning media attention for our hobby, and making a local tie to the heritage of amateur radio!

In other news, the club's assistance to the Charlie Post Classic Run on January 27, 2007 was a great success. Race Director, Joanie Mulvihill, was thoroughly impressed with our organization and professionalism, and expressed the thanks of the Charleston Running Club. My thanks to the race crew who helped make the support possible with one of our club's largest events just a week away.

Of course, I am speaking of our Hamfest, on February 3, 2007. This will be the ARRL State Convention, and we anticipate a great turnout. Recent work with various agencies to train amateur radio operators signals that we will have a large turnout for VE testing for prospective new Hams. As I have written before in this column, getting the license is only the start. I look forward to having the club well represented at our Hamfest. We have a busy year ahead as we help these new Hams get engaged in the hobby, and learn to translate the knowledge required to pass a licensing exam into real operating skills on the amateur bands.

#### PA SYSTEM

The PA (Pubic Address) system is used at the club meetings to make it easier for everyone to hear the reports and announcements. If you have a report or

announcement to make and do not use the PA system, then many people on the other side of the room from you can not hear what you are saying. As we grow older our hearing, among other things, deteriorates and even though Ken may be able to make out what you are saying, others can not, so, when you have a report or announcement to give, please walk up to the microphone and use it properly so that everyone can hear you.

Using the PA microphone is different than using your transceiver microphone. When you use your transceiver microphone there is no audio feedback but when you use the PA microphone properly you can hear your voice coming from the PA speakers. Many people back away from the PA microphone when they hear their voice coming from the PA speakers. The problem with this is that, if you can not hear your voice coming from the speakers, neither can other people, so, please step up to the microphone and use it so everyone can hear your report or announcement.
