# FROM THE PRESIDENT

I regret that I missed the chance to write a column for this space last month. I spent all of my available "ham" time at Field Day, and it was much better to get the newsletter out on time! So with that, I'll try to make up some ground this month.

I left from Field Day this year very satisfied that we had done something very special. When someone asked me if we were making a lot of contacts, I had to admit that our number of QSOs was not that impressive. But what we did accomplish was something much more exciting. By that I mean that we had experienced Extra and General Class Hams working side by side with our newer Technicians on operating skills. I watched the excitement in the faces of these new Hams as they gradually gained confidence on the air - picking out distant contacts out of the pile-ups and QRM. There were lots of "high fives" and excitement!

The patience exhibited by these elmers helped capture the excitement of HF operation – the bedrock of amateur radio that is largely out of the reach of the entry license class. Having one-on-one help eased a lot of "mike fright", and by the end of the event solidified the commitment of some of our newest members to upgrade to higher license classes. Of course, there were a fair number of people who already intended to upgrade, but there were no doubt several folks on the fence about making the effort to study for an upgrade.... They're off the fence now! The ARRL Board recently set a goal of attaining 30,000 new licensees in 2008, increasing in the following years. Our patience and mentorship is the way for us to do our part in helping achieve this goal to create real growth in the Amateur Radio Service.

In addition at Field Day, we had a visit by Ray Toler, Charleston County School Board member, who expressed his amazement at the activities. He had no idea of the range of activity in today's amateur radio. We had a couple of hours with Mr. Toler, and had the chance to talk about amateur radio from several aspects – particularly the many educational aspects of the hobby when incorporated in schools in the context of math, science, geography, and other subjects.

There was also good conversation about how to make next year even better, including discussion on how to make CW more accessible to newcomers. All in all, we had one of the smoothest Field Day operations I have witnessed, thanks to a lot of our members stepping up to help with set-up, moving items up to the club room, and tear-down. Thank you all for your participation, and a special thanks to our Field Day captain, Doc (W4MUR).

In other events, the QSO cards from our Museum Ships event on June 9<sup>th</sup> and 10<sup>th</sup> keep coming in! To me, the volume of activity speaks to the powerful impact of having the USS Yorktown as an operating base. Our operating capability from U.S.S. Yorktown deserves to be a big focus in the coming year. And several other projects are shaping up with Patriot's Point that I hope we'll be talking about soon.
