#### FROM THE PRESIDENT

We've all seen them.... Drivers oblivious to the surrounding traffic, jabbering on their cell phones in the midst of the morning commute. It is a growing national problem in our always connected "information age", and one that individual states are now trying to address with so called "Hands Free" laws.

Recently, I found out that there is a bill in the South Carolina Senate, S.1133, which will require the use of hands free devices in vehicles driven in South Carolina, while the vehicle is in motion. As this bill is presently worded, it does not make provisions for the operation of Amateur Radio equipment installed in vehicles. It does, however, provide an exemption to law enforcement, emergency management service, and fire department officials and personnel when they are performing their official duties. Similar language in other state laws has been interpreted to preclude the use of ham radio microphones while driving.

My sense is that the overwhelming majority of our state's more than 10,500 federally licensed radio amateurs are responsible people. It is that sense of responsibility that moves so many of us to volunteer our time, talent and treasure in support of our communities and relief agencies during an emergency or disaster. I also note that hams are particularly conscious of how careful they must be in operating a radio while driving. Many a QSO ends with one party noting that they need to go QRZ to keep both hands on the wheel! I encourage each member of the CARS club to write to their SC legislators to express their desire to see this bill modified to provide for the

licensed operation of amateur radio equipment. Find your legislators, and send an email from the SC Statehouse website at www.scstatehouse.net.

In other news, Doc (W4MUR) continues assembling the 2008 Field Day team for our operations on USS Yorktown on June 28-29. As we discussed at the last meeting, we need lots of hands and strong backs to move equipment up the stairs and ladders. Field Day is a good way for our newer hams to learn the skills to set up a full blown HF station under field conditions. With a good cadre of club members under Doc's capable direction, I'm looking forward to a successful event. We've invited a number of dignitaries to our operations, including Governor Sanford Charleston Police Chief Mullen. But more important, we need you to come and show your support, and share the excitement with your friends and family.

Please join me at our next club meeting at Ryan's Steak House on May 12<sup>th</sup>. I look forward to seeing you there to solidify our plans for Field Day, and many more activities in the coming months.

# EXAMPLE E-MAIL/LETTER TO YOUR SC LEGISLATOR

Dear Senator Campsen,

There is a bill in the South Carolina Senate, S.1133, which will require the use of hands free devices in vehicles driven in South Carolina, while the vehicle is in motion. As this bill is presently worded, it does not make provisions for the operation of federally licensed Amateur Radio stations installed in vehicles. It does, however, provide an exemption to law enforcement, emergency management service, and

fire department officials and personnel when they are performing their official duties. I understand that this bill has been referred to the Transportation Committee on which you serve.

I would request your consideration of a modification of S.1133 to provide for the operations of a federally licensed Amateur Radio operator. In similar fashion to other exemptions presently in the bill, this would maintain the ability of the FCC licensed Amateur Radio Service to continue to provide valuable assistance to law enforcement and other public safetly personnel in a mobile environment.

The overwhelming majority of our state's more than 10,500 federally licensed radio amateurs are responsible people. It is that sense of responsibility that moves so many of us to volunteer our time, talent and treasure in support of our communities and relief agencies during an emergency or disaster. I also note that hams are particularly conscious of how careful they must be in operating a radio while driving. The issue that inspired the bill is *driver inattention* and not the electronic technology itself, and radio amateurs are trained and tested to ensure responsible operation of their equipment.

#### **Introductions:**

There were 33 members and 3 guests present.

Next, Ken recognized Bryce & Jenny Myers for being inducted into the Bridge Run Hall of Fame for their years of volunteer service to the Bridge Run. They were featured in a special interview in the 2008 CRBR Magazine.

After the Bridge Run Ride-April 6<sup>th</sup> - Ken thanked Doc, W4MUR, for serving as net control for the event. In addition, Ken thanked those who volunteered, many of whom had just worked the Bridge Run the day before.
